Course Description

This course introduces the field of Museum and Heritage Studies by examining heritage sites, museums, art galleries, zoos, natural parks and others. Traditional institutions will be examined along with new forms, including virtual museums.

1. To introduce students to concepts of heritage, artifact, and patrimony;
2. To introduce students to the idea of and history of museums and heritage sites;

4. To introduce students to critical issues in museum and heritage studies.
