Course description	Continuing focus on developing choreographic structures that support clear artistic statements, with an emphasis on the duet form. Course Hours: 3 units; (2S-2) Antirequisite(s): <i>Credit for Dance 431 and 430 will not be allowed.</i>
Course overview	Choreography is the organization of bodies in space and in time. Each choreographic practice is unique and can originate from an infinite number of inquiries of imagination, culture, place, body, structure, gender and much more. In order to be coherent, a choreographer must be knowledgeable of the practical, theoretical, aesthetic and historical continua that they are part of. Additionally, a choreographer must realize their own voice and vision through experimentation, practice and choice. Through in- class study and assignments, students will practice a variety of compositional methods and strategies. Through in-class discussion, exercises of doing and viewing, students' will develop skills to formulate critical responses to the dances they see, create, and perform.

	<p><u>Late Assignments</u> Late assignments will have 10% points deducted per late day.</p> <p>FOR GRADED DANCE STUDIO COURSES</p> <ul style="list-style-type: none"> • A significant part of your grade is based on participation. Participation means not only showing up for class, but also attending to the material at hand with effort and engagement. • With regard to participation, classes are considered equivalent to assignments. Thus, more than 2 absences per term will have an adverse effect on your final grade. • If you miss more than one week of classes, your final grade will begin to drop by as much as 10% per missed class. • If you miss more than two weeks of classes (4 classes), you have the potential to fail the course. • If you show up late for or leave early from class, this will be counted as half an absence. • If for some reason you are feeling unwell during class time, a substitute form of participation may be arranged; however, you may not obtain this privilege more than once and you will receive half an absence. • Students are responsible for any and all material missed during an absence • If you sustain a significant injury during the term that will impact your participation for longer than a week's worth of classes and if this injury is verified by a medical practitioner's note, your case will be submitted to the Dance Division Committee to address your situation.
