Prerequisites	Drama 242.

Course description	Continued study and practice of drama, theatre and performance.
Course learning outcomes	By the completion of this course, successful students will be able to: <ul style="list-style-type: none"> • Observe, describe, and analyze key aspects of a live performance. • Use discipline-specific vocabulary to discuss theatre. • Identify and discuss the roles different theatre makers play in a production. • View and discuss theatre from different aesthetics and disciplines. • Investigate theatre through an inter-disciplinary lens.
Course schedule	The course will be broken-up into four areas of investigation: Playwriting: Jan 15 to Jan 29. Directing: Feb 5 to Feb 14. Design: Feb 19 to Feb 28. Devised Creation: Mar 5 to Mar 14. *Each area will include a classroom visit and discussion with a working professional and/or instructor. Selections from Peter Brook’s book will be assigned throughout the course. <ul style="list-style-type: none"> • A deep dive into <i>Machinal</i>. • Quiz #1 – January 31. • <i>The American Play</i> by Susan-Lori Parks. • Play Analysis Paper of <i>Machinal</i> handed-in – Feb 19 • <i>Fences</i> by August Wilson. • Quiz #2 – March 5th • Group Presentations - March 19th to April 4th. • Final Quiz – April 9th.

<p>Assessment components</p>	<ol style="list-style-type: none"> 1. Three quizzes 10% (30%) These quizzes (short answer and multiple choice) will be based on readings and the in-class discussion within a selected section of the course. 2. Play/Performance analysis: <i>Machinal</i> (20%) Length – 500 to 800 words. Students will reflect and analyze one or two elements from the live performance (Direction, aesthetic, design (set, lights, sound), performance, adaptation) and bring in references from past-production through reviews and articles, and also attempt to answer the question: <u>Why this play now?</u> A bibliography or works cited is required – citing the production as well – in MLA style. Be clear and concise when organizing your thoughts, large definitive statements/opinions should be avoided unless backed-up with detail within the paper. 3. Group presentation (40%) Length – 20 minutes This group project will be on any play within the Norton Anthology: not covered in either 243 or 242. The presentation will be ‘performed’ in front of the class, with students taking turns presenting research discoveries including, but not limited to, a brief history of the play, reception of the play, influences or inspirations, and different, if any, interpretations of the play. A short scene (2 to 4 minutes) from the play will also be performed, with some minor production elements (costumes, lights, sound...) *This presentation should also be performed <i>in the style</i> of the play itself. A group document should be handed-in the day of the presentation, detailing the individual group member’s research – 2 pages per section. <p>Participation (10%)</p>
<p>Assessment expectations</p>	<p><i>Participation:</i> <i>Demonstrates punctual attendance, interest in the work, concentration, focus and commitment to class and group projects, preparation, and an overall positive contribution to class discussions and activities.</i></p> <p>A documented illness or family emergency is an acceptable reason for late written work or inability to make scheduled presentations. In the case of a missed oral presentation or class participation assignment, the instructor would appreciate advance notification if possible. FOR GRADED DANCE STUDIO COURSES

- A significant part of your grade is based on participation. Participation means not only showing up for class, but also attending to the material at hand with effort and engagement.
- With regard to participation, classes are considered equivalent to assignments. Thus, more than 1, 2, or 3 (fill in based on how many times the class meets per week) absences per term will have an adverse effect on your final grade.
- If you miss more than one week of classes, your final grade will begin to drop by as much as 10% per missed class.
- If you miss more than two weeks of classes, you have the potential to fail the course.
- If you show up late for or leave early from class, this will be counted as half an absence.
- If for some reason you are feeling unwell during class time, a substitute form of participation may be arranged; however, *you may not obtain this privilege more than once* and you will receive half an absence.
- For studio courses, if you opt out of full participation and choose to sit for a portion of the class, this will be counted as non-participation and will be marked as half an absence.
- Students are responsible for any and all material missed during an absence.
- If you sustain a significant injury during the term that will impact your participation for longer than a week's worth of classes and if this injury is verified by a medical practitioner's note, your case will be submitted to the Dance Division Committee to address your situation.

FOR PASS/FAIL DNCE COURSES

- Due to the experiential nature of this course, classes are equivalent to assignment. Therefore, classes missed will be detrimental to the final grade. More than four (4) missed classes will result in a fail for the course.

SCPA Claim Your Seat Program: Student Guidelines	<ol style="list-style-type: none"> 1. The Claim Your Seat (CYS) program allows all University of Calgary students to attend on-campus School of Creative and Performing Arts (Dance, Drama and Music) events free of charge. 2. Depending on the performance, there is a limited number of seats available for CYS. There is not a guarantee that tickets will be available for all CYS patrons for every performance, based on audience size, demand, etc. 3. CYS tickets are a privilege. If a student receives a ticket to attend a performance, it is expected that they will respect the value of the admission and attend the performance. 4. Process for students: On the date of the performance, from the time the Box Office opens until 15 minutes prior to the performance start time, students should find the UTS staff member with an iPad and show their UCID card to print their CYS ticket. If students arrive after 15 minutes prior to the performance start time, they can also go to the Box Office and purchase a ticket at the student rate. Students should not go to the Box Office unless they are purchasing a ticket. 5. they can find a UTS staff member with an iPad and get their CYS ticket from them. 6. If students have a course requirement to attend a performance for a specific date, access to the tickets will be communicated by the instructor to University Theatre Services prior to the event. The best guarantee for a free ticket is to arrive early, up to 45 minutes prior to the performance start time. 7. Respect for the Front of House and theatre staff, performers and fellow patrons is an absolute requirement. Failure to comply with this will lead to being asked to leave the venue and could result in the revoking of CYS privileges.
