Prerequisites	None. It should be noted, however, that this course needs the ability to read music fluently and is the first of three foundational courses in music history intended for B.Mus. and B.A. (Music) students. It is not intended as an "option" course for the general university student.
Course description	<p>The course will offer the student a guided study of the music, history, and culture of Western Europe between the years (approximately) 900 and 1700 A.D. Central to the course will be the musical (listening) selections that will trace the development of musical style during these years. The course content will focus upon the meaning and artistic substance of such important period style terms as the Middle Ages, the Renaissance, and the Baroque, together with a consideration of the major composers of each style period. A detailed list of the works to be studied (related to the readings from the text) will be provided in the course syllabus.</p> <p>The course will consist of a series of 10 study "modules" involving readings from the text, listening examples, and questions to be answered based on the readings and listening examples contained in the accompanying anthology. The answers (short answers and short essays) to these questions will be submitted by E-mail for grading. There will also be three listening tests. (See details below.)</p>
Course learning outcomes	<p>By the completion of this course, successful students will:</p> <ol style="list-style-type: none"> 1. Have a knowledge of a selected repertoire of music from the Medieval, Renaissance, and Baroque periods from about 900 to 1700 A.D. 2. Have a knowledge of the basic facts of Western European history during the same period. 3. Understand the basic principles of composition that inform musical culture from 900 A.D. to 1700. 4. Have a listening knowledge of the different musical styles found in the period from 900 A.D. to 1700.
Course schedule	Each Thursday individual members of the class will be sent an E-mail containing the weekly assignment. The completed assignment will be due the following Monday (by noon). It will be graded and returned at the time of the following

	<p>assignment (the next Thursday).</p> <p>The listening tests (also on Mondays, except the final test) will take place approximately once per month. The listening tests are non-cumulative.
